How a domestic energy storage system compared to last year?

In the first half of the year, the capacity of domestic energy storage system which completed procurement process was nearly 34GWh, and the average bid price decreased by 14% compared with last year. In the first half of 2023, a total of 466 procurement information released by 276 enterprises were followed.

How much does EPC cost in 2023?

As of December 2023, the bidding unit prices for ESS and EPC stand at 0.77 yuan per watt-hourand 1.45 yuan per watt-hour, respectively. In certain regions, standalone Energy Storage System (ESS) power plants are already yielding returns.
