By 2030, Spain expects to install 22.5 GW of energy storage projects, including included battery energy storage, pumped hydropower and solar thermal plants. The plan also aims for 76 GW of solar power, 62 GW of wind power, which includes 3 GW of offshore wind, along with 1.4 GW of biomass projects.

When supplemented by active data monitoring from all points of the energy chain as well as smart automated functionality, on-site energy storage capacity becomes one part of an integrated energy management system while enabling container handling operations at the terminal to become locally free of exhaust emissions.

Over 50GW of new renewable energy capacity is planned to meet these goals, including 20GW of wind and 30GW of solar, while nuclear and coal plants are scheduled for phaseout. Spain has also set a target of deploying 20GW of energy storage by 2030 in a national energy storage strategy, the biggest target seen anywhere in the world for storage.

The announcement marks the beginning of Spain's new auction mechanism, which foresees a total of around 19.4GW of renewables to be assigned through auctions between now and 2025, with at least 10GW of that capacity to be solar PV. The pay-as-bid system will allow hybridisation between technologies and be compatible with energy storage.
