A spokesperson for Tesvolt, a German designer and manufacturer battery energy storage systems, told Energy-Storage.news that the demand for large-scale storage systems up to 10MWh is currently increasing. The Innovation Tenders are a significant driver of this demand, along with a growing number of hydrogen projects.

Since Chile passed a major energy storage bill, gigawatts of energy storage co-located with solar PV are being built in the country. Earlier this year the country opened a public land bidding auction seeking 13GWh of standalone energy storage projects across four regions - Arica and Parinacota, Tarapaca, Antofagasta and Atacama.

On 25 July 2024, the Bulgarian Ministry of Energy closed the open discussion on the terms and conditions for the upcoming battery energy storage system (BESS) tender, deciding that more than 3000 MWh will be funded by grants from the EU's Recovery Resilience Facility.1.

The four projects offered in the tender include the 500-MW Al-Muwyah and 500-MW Haden battery energy storage projects in Makkah province, the 500-MW Al-Khushaybi project in Al-Qassim province and the 500-MW Al-Kahafa project in Hail province. All four batteries will have a storage period of four hours.

Australian energy minister Chris Bowen has said tenders for 500MW of renewable energy backed with energy storage will open in the middle of this year in Western Australia (WA). The tender will be held as part of the Capacity Investment Scheme (CIS) launched by the government of prime minister Anthony Albanese's Labor Party, considered by many ...

The reverse auction was launched with a Notice Inviting Tender (NIT) issued by SECI on 15 March for the Request for Selection (RFS). Buying entities for the solar-generated power will set 2-hour periods each day during which energy will be drawn from the energy storage system (ESS), determined on a day-ahead basis.

The Bulgarian Ministry of Energy has invited public comment on a new initiative to offer tenders for 3GWh of energy storage capacity to help integrate renewable energy. In its current form, the tender consists of BGN1.2 billion (US\$660 million) in grant funding. Projects cannot apply for funding to cover more than half of their costs, and ...

In the previous round of generation and long-duration energy storage tenders, one LDES project was successful, a battery energy storage system (BESS) project proposed by RWE with 8-hours" duration, alongside three generation projects, as reported by Energy-Storage.news earlier this month.

A total of 4,000MWh of pilot tenders for standalone energy storage are expected to be launched in total by the government of India. This is in addition to activities at state level, such as the current 500MW tender for renewables with storage being run by the electricity board in the state of Gujarat, to give one example.

The first tender, with a total budget of BGN 107.6 million, will finance the construction of solar and wind projects and co-located energy storage facilities with installed capacities between 200 kW and 2 MW. The procedure seeks to facilitate the development of at least 200 MW of renewable energy production and 100 MW of energy storage.

Comparing tenders activity in energy storage segment in different regions of the globe, North America held the top position with ten tenders and a share of 45.5% during June 2021, followed by Asia-Pacific with six tenders and a 27.3% share and Middle East and Africa with four tenders and an 18.2% share.

The tender is calling for submission of bids for energy storage projects totalling 616 MW / 2464 MWh at pre-selected substation sites identified by Eskom. BESIPPPP is a grid-scale energy storage programme for procurement of energy storage systems from private energy storage companies. The battery storage procurement programme is aimed at ...

After a January announcement that revealed some of the bidders had included big players in the region such as ACWA Power and Masdar, Energy-Storage.news last week enquired via the Ministry of Energy and Mineral Resources (MEMR) on the status of the tender process.
