Will Israel build its first large-scale energy storage project?

JERUSALEM, May 2 (Reuters) - Israel's Energy Ministry said on Tuesday that it was moving forward with a plan to build the country's first large-scale energy storage project.

Should Israelis erect solar panels on domestic roofs?

Last July, the Energy Ministry and the Electricity Authority launched a campaign to persuade Israelis to erect solar panels on domestic roofs, which would earn them money for surplus energy that goes into the grid and help cut pollution.

How will solar energy impact Israel's economy?

The plan would see more than 80% of Israel's electricity generated by solar energy at peak hours. "This is an investment of NIS 80 billion (\$22 billion) over the next 10 years. It's a huge economic engine that will create a great many jobs and reduce pollution," Steinitz said in a statement.

Will EVs be banned in Israel?

The Israeli government declared that the sale of petrol and diesel vehicles will be banned by 2030. However, how this target will be achieved remains vague. In addition, Prime Minister Naftali Bennet announced that Israel has set a goal of net zero emissions by 2050. This will have to translate into a faster transition to EVs.

Sweden has announced a government subsidy that will cover 60% of the cost for installing a residential energy storage system, up to a maximum of 50,000 kroner (US\$5,400). Battery, wiring, management systems and installation will all be eligible for payment under the subsidy.

The reduction is mainly due to the retreat of Superbonus subsidy policy. Italy"s energy storage structure is also dominated by residential storage, which accounts for more than 80% of new installations. Various regions have introduced investment subsidies for energy storage projects.
