

What is the implementation plan for the development of new energy storage?

In January 2022, the National Development and Reform Commission and the National Energy Administration jointly issued the Implementation Plan for the Development of New Energy Storage during the 14th Five-Year Plan Period, emphasizing the fundamental role of new energy storage technologies in a new power system.

Why is China's energy storage capacity rocketing?

BEIJING, Jan. 25 -- China's energy storage capacity is rocketing to facilitate the utilization of growing renewable power amid the country's efforts to pursue low-carbon development. China's installed new-type energy storage capacity had reached 31.39 gigawatts by the end of 2023, the National Energy Administration (NEA) said on Thursday.

Will China expand its energy storage capacity by 2025?

China aims to further develop its new energy storage capacity, which is expected to advance from the initial stage of commercialization to large-scale development by 2025, with an installed capacity of more than 30 million kilowatts, regulators said.

What is the 'guidance on accelerating the development of new energy storage'?

Since April 21, 2021, the National Development and Reform Commission and the National Energy Administration have issued the 'Guidance on Accelerating the Development of New Energy Storage (Draft for Solicitation of Comments)' (referred to as the 'Guidance'), which has given rise to the energy storage industry and even the energy industry.

When will new energy storage development be introduced?

The commission said earlier it will introduce a plan for new energy storage development for 2021-25 and beyond, while local energy authorities should also make plans for the scale and project layout of new energy storage systems in their regions.

What are China's Energy Storage plans?

On 15 July, national plans for energy storage were set out by the Chinese National Development and Reform Commission and National Energy Administration. The main goals of new energy storage development include: Full market development by 2030. 1) Strengthening planning guidance to encourage the diversification of energy storage;

The Long-Duration Energy Storage (LDES) portfolio will validate new energy storage technologies and enhance the capabilities of customers and communities to integrate grid storage more effectively.
